Financial Statements for November 30, 2024 – Mr. Zuckerman presented the Statement of Financial and Comprehensive Income Statements for November 30, 2024, in detail. He informed the Board that the Variance is high but will be reduced once Providers' contracts are amended and they start to draw down the dollars. A motion to accept the Financials as presented was made by Ms. Jackson and seconded by Mr. Franklin. The motion passed unanimously.

#### • President/CEO Report

SFBHN/TMSF Contract Update- Dr. Newcomer gave an overview of the ITN process and where we stand at this time. He went on to say The Department of Children and Families (DCF) has decided that they will contract with Thriving Mind South Florida (TMSF) and TMSF will be working with DCF to execute for a full contract before our present contract ends June 30, 2024. The new contract is a five (5) year contract with another non-compete renewal contract of five (5) years, giving Thriving Mind a total of 10 years. It was noted that an official notification is coming.

There was a brief conversation regarding Community Behavioral Health Clinics/Centers.

**Government Consultant/Lobbyist** - Dr. Newcomer informed us that Thriving Mind South Florida has engaged the services of Mr. Ron Book, who will assist Thriving Mind with its vision and mission.

Thriving Mind E-mail Domain and Trademark Status – Dr. Newcomer gave a brief overview of Thriving Mind's rebranding and trademarks. He introduced Carrie Ann Liberante, Sr. Director of Communications and Strategic Initiatives, who gave a brief description of the processes taking place regarding the e-mail domain and trademarks. She informed that the SFBHN emails have been migrated over to Thriving Mind. And she went on to say that the State's Trademark was approved last fall. The Federal process must be documented and submitted in April 2025 and will keep the Board updated as we move forward to that date.
