• Treasurer's Report	<p>Financial Statements for July 31, 2025 – Mr. Stephen Zuckerman presented both the Balance Sheet and Comprehensive Income Statement in detail. Mr. Zuckerman informed that this information does not include the budget, which will be presented at October 13, 2025. Finance Meeting. As a note, Mr. Zuckerman informed the committee that TMSF continues to work on the closeout, and DCF should approve our revised information shortly. Schedule of funds #2 has been received, amending Providers' contract to implement. Schedule of Funds #3 will be received in the next week or so and we will report on this at the October meeting. TMSF General Revenue Carry Forward for fiscal year 24-25 is 7.21%, which is below DCF's target of 8%,</p> <p>Mr. Zuckerman reminded the committee that the Variances continue to improve as providers draw down the funding.</p> <p>A motion to accept the Financial Statement as presented was offered by Mr. William "Ted" Franklin and seconded by Mrs. Racher. The motion passed unanimously.</p>

<ul style="list-style-type: none">• President/CEO Report	<p>Camillus House Update – Dr. Newcomer advised that Camillus House has still not submitted an Annual Financial Aduit. As of July 1, 2025, due to this and other monitoring issues, TMSF was unable to renew their contract at this time. A meeting was held with Camillus House to determine the next steps. As a note, Camillus is in the process of making full restitution. As this process moves forward TMSF will keep you updated.</p> <p>Implementation of New Required Performance Measures – Dr. Newcomer stated that with TMSF’s new contract with DCF there are required frequent performance measure reports, some driven by contract and some by proviso. These new reports have required new data collection from Providers and TMSF itself. As of now all the HB633 Proviso Funding performance measures have been submitted to DCF and we are on track to meet all other new reporting requirements.</p> <p>Miami Dade County Budget Cuts – Dr. Newcomer stated that TMSF is not directly affected by the cut some of its CBO providers are. At the Jewish Community Services request, the Board penned a support letter to the Miami Dade Board of County Commission (BCC) asking for relief of the cuts to the CBOs. The next BBC public meeting is September 18, 2025, and we will keep this committee updated.</p> <p>Need Assessment – Dr. Newcomer stated that Triannual Needs Assessment had been completed, and a final draft will be sent to the Executive Committee after this meeting for any feedback, after which the final version will be sent to DCF.</p>
